## Applying for a Permit to Carry a Handgun

*Online FARS application, Both Initial and Renewal Applications*

**Toms River Police Department's ORI# is NJ0150700**

**Please Note – You must already have a Firearms ID Card/SBI # and handgun(s) before proceeding.  
FID Card must have current Toms River address.**

Applications filed online must come in person with following items:

- 1) Driver's License and Birth Certificate (copy from office of Vital Statistics only) OR Driver's License and Passport OR and Driver's License and Naturalization Paperwork/Green Card.
- 2) NJSP proof of training and safe handling form, sp 182 (rev 9/23) can be uploaded or handed in
- 3) Photo should be uploaded, check FARS
- 4) Mental Health is automatically sent with system. Check for Out of State
- 5) Written proof of ownership with the handgun(s) you intend on carrying.
  - a. Proof of ownership can be a purchase receipt or purchase permit or a notarized letter of ownership listing make, model, and serial number of handgun(s)
  - b. Additional handguns intended to carry form sp182a (rev 6/23) if you intend to carry more than one handgun.
- 6) Money order, Check, Cash or Credit in the amount of \$150.00 payable to "Toms River Township"
- 7) Online applications do not need fingerprints
- 8) Current Firearms ID Card copy
